Uniform reminder

We have noticed over the last few weeks an increasing number of students whose trousers and skirts do not meet the requirements set out in the school uniform guide (https://lsg.kevibham.org/about-us/uniform-guide/). Please can you check that your

daughter's school skirt and trousers still fit and use half term to purchase new ones if required.

If they are only slightly too short, a good tip is to unpick the hem and iron out the crease - as there is usually a sizable amount of fabric contained within the hem.

Can we also remind families that we do not permit any piercings except 1 plain gold or silver stud in the lobe of each ear. We therefore encourage you to wait until the start of the summer holidays if your child would like any new piercings that do not meet these requirements.

Online safety

Holidays are when we find an increased number of reported issues relating to online usage. Whilst we can monitor what students are doing on school devices, we do not have this ability on personal devices. We ask that parents are extra vigilant during holidays and weekends regarding their child's online presence.
